My walks in the forest, by the river, the ocean and my work in the garden provide a constant source of imagery and synergy for my work as an artist. I explore the subtlety and rhythms of nature and urban environments through observation and experience.

Bringing these to my studio practice, my work often consists of both representational and abstract imagery. I explore ideas generated by naturally occurring indicators, such as movement, climate and light, all which later dictate the media choice, using drawings, painting, printmaking and photography, alone or in combination, allowing me freedom in the process of creation. Creating work allows the viewer to 'get lost' in what they see is the ultimate compliment

RESTRICTIONS

- ◆ Must be framed or finished edges and wired for hanging.
- ◆ Complete label, tape to front/back of artwork.
- ◆ Artist must hand-deliver & pickup work at Easton Library.
- ◆ Art must be available for sale from delivery till end of show.
- ◆ Artwork must not have been in any previous EAC Shows.
- ◆ Size limitation, no larger than 40" x 40".
